To Whom It May Concern:

In response to concerns of the usage of phthalates in our sheets, Kömmerring USA standard sheets (Kömatex/Kömacel) contain no phthalates in the base PVC compounds used in our process.

Our standard White and Black sheets **Do Not** contain any *DEHP, DBP, DINP, DIDP, DnOP* or *BBP*. Our standard Colors do not contain any of the above mentioned with the exception of Dk. Grey (on occasion) and Purple.

We are currently researching other alternative colorant sources for elimination of any trace of phthalates. The colors that contain a small amount of phthalates are special order colors and the above mentioned standards. We urge our customers to contact us on concerns of any of our products.
